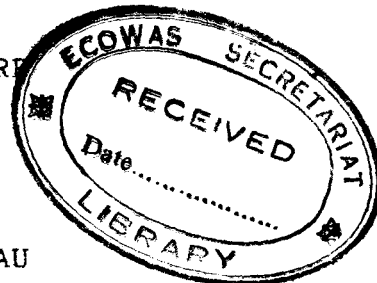


I. INTRODUCTION

1. The thirty-seventh session of the ECOWAS Council of Ministers was held at the International Conference Centre, Accra from 24 to 27 July 1995.

II. OPENING SESSION

3. In his opening speech, Dr. Kwesi Botchwey, Minister of Finance and Economic Planning of the Republic of Ghana, Chairman of the Council of Ministers, welcomed Ministers, Central Bank Governors and their respective delegations, on behalf of President Jerry John Rawlings and the Ghanaian Government and people. The Chairman of Council reviewed progress made by ECOWAS in its twenty years of existence and stated that the regional organisation had had a low impact on economic development in Member States. He stressed the need to identify factors obstructing regional integration and to propose remedial solutions. Among these factors, the Chairman noted, were the lack of political will in Member States, as portrayed by the non-implementation of Community programmes and irregular payment of financial contributions to the budgets of the Community Institutions. He urged countries in the sub-region to take their destiny into their own hands by playing a more effective role in regional integration efforts.

4. Analysing the economic situation in the sub-region, the Chairman of Council stressed the need for Member States to create a healthy economic environment conducive to growth. He stated that policies needed to be adopted to bring about an increase in public and private savings, to yield funds for greater investments in the sub-region. He called for a favourable

environment to facilitate market integration in West Africa and reduce the cost of commercial transactions. He added that such market integration would encourage economies of scale conducive to the development of the production sectors.

5. The Chairman of Council made a brief review of the Community work programmes and referred specifically to the deliberations of the Consultative Forum, implementation of the Minimum Agenda for Action, the first ECOWAS Trade Fair and a number of other programmes in infrastructural and production sectors.

6. In conclusion the Chairman of Council stressed the need to adopt a regional approach to resolving critical issues pertaining to sub-regional development. He expressed the hope that this session of Council would analyse objectively problems facing ECOWAS and take decisions that would move the Community towards the effective integration of West African economies.

V. OUTCOME OF DELIBERATIONS

Item 3 Presentation of the report of the Executive Secretary

9. The ECOWAS Executive Secretary, Mr. Edouard Benjamin, presented his 1994/95 annual report entitled "Addressing the Problem of Implementation". The report highlighted the poor economic performance in the sub-region in 1994 and indicated that there had been a marked overall downturn in economic activity within ECOWAS despite the favourable trends in UEMOA countries. Average real GDP growth in West Africa dropped from 2.3% in 1993 to 1.8% in 1994. The sharp fall in production in Nigeria due to domestic political tension and economic regulatory measures introduced in 1994, and civil wars in Liberia and Sierra Leone

were some of the factors responsible for the declining economic growth in the sub-region.

10. The report stated that growth prospects should be good because of the expected rise in world commodity prices and the economic changes that have taken place in most ECOWAS countries. The devaluation of the CFA franc, for example, had resulted in greater competitiveness of UEMOA states and the creation of a growth-inducing economic environment. Countries outside the CFA zone had also intensified their adjustment efforts.

11. In the chapter on the performance of the Community, the Executive Secretary gave an account of the implementation of ECOWAS socio-economic programmes since the 1994 Summit. In particular, he drew Council's attention to the harmonisation of macro-economic policies, the first ECOWAS Trade Fair, cooperation programmes in the field of production, regional peace and stability and the activities of the ECOWAS Fund.

12. The report noted that the Community, which was celebrating twenty years of existence, had again been faced with lack of commitment from Member States regarding implementation of ECOWAS integration programmes. As a result, the performance of the Community institutions during the review period had been seriously affected by persistent cash flow problems. Only two countries owed no arrears of contributions to the Executive Secretariat and two other States had fulfilled their financial obligations to the ECOWAS Fund. The Executive Secretary stated that the considerable arrears accumulated had made it impossible for the Community Institutions to implement their programmes properly.

13. Speaking on the need for effective implementation of Community acts and decisions as a means of accelerating regional integration, the Executive Secretary focused on other areas which affected programme implementation. Among these were technical preparation for meetings by Member States, inappropriate domestic measures to promote implementation, insufficient allocation of resources for regional integration and inadequate capacity of the institutions to design regional integration programmes.

14. The Executive Secretary's report also laid emphasis on the need to remove impediments to regional integration, involvement through firmer commitment of Member States to the integration process and greater popular and private sector involvement in integration efforts.

15. The Executive Secretary concluded his report by highlighting the need to create an environment conducive to regional integration, supported by the pursuit of the concepts of democratisation and economic liberalisation.

16. Council congratulated the Executive Secretary on the quality of his report. Having discussed the issues raised therein, Council took due note of the report and made the following observations and recommendations :

- i) Council noted that the performance of the Community Institutions was below expectation and that this had seriously affected their credibility. This was due in large measure to the non-implementation of decisions adopted by Member States in all sovereignty and the irregular payment of contributions by Member

States to the budgets of the Community.

- ii) With regard to the implementation of Community Acts and Decisions, Council appealed to all Member States to ratify the revised Treaty by December 1995 and the other Protocols and Conventions before July 1996. Council also directed the Executive Secretariat, in future, to prepare a memorandum on the status of ratification of Acts and Decisions as well as the implementation of integration programmes. The Secretariat was requested to translate the legislative texts into Portuguese before September 1995 to enable Cabo Verde and Guinea-Bissau to have their respective parliaments ratify these texts within the prescribed time limits.
- iii) On the strengthening of the capabilities of Member States to ensure more effective execution of Community programmes, Council recognised the important role of national units in the implementation process. The Secretariat was urged to convene regular meetings of heads of ECOWAS units to work out ways of enhancing their performance.
- iv) Concerning the critical financial situation of the institutions, Council expressed concern at the extremely high level of arrears and enjoined Member States to respect the July 1994 Abuja resolution on payments of arrears. Member States which were yet to negotiate and sign payment

countries whose countries which had already signed such agreements were advised to respect the terms of the payment schedule. Council added that failure to comply with these directives would result in the application of sanctions, as envisaged in the revised Treaty.

- v) With respect to repayment of loans granted to Member States by the Fund, Council directed the Management of the Fund to continue to apply the relevant sanctions to defaulting states.
- vi) Members of Council reaffirmed the commitment of all Member States to the consolidation of regional integration. Council stressed that this must manifest itself in concrete action, notably by the application of Community programmes and payment of financial contributions.
- vii) Council called on the institutions to rationalise expenditure and manage available resources more effectively.
- viii) Council took note of efforts being made by the Federal Republic of Nigeria to make available 100 housing units to the Executive Secretariat in Abuja. The Secretariat was directed to finalise the loan agreement for the construction of staff residences in Abuja with the Nigerian authorities.

Item 5 Consideration of the report of the Seventeenth Meeting
of the Committee of Governors of Central Banks;

Item 6 Consideration of the report of the third
Consultative Forum

17. The Chairman of the Committee of Governors of Central Banks and the Chairman of the Consultative Forum presented the report of the seventeenth session of the Committee of Governors and the report of the third Consultative Forum respectively. Both reports focused essentially on the harmonisation of economic and financial policies and the formulation of a regional development programme.

18. Council congratulated the Committee of Governors and the Consultative Forum on their serious approach to issues pertaining to the development of the sub-region.

19. Council reiterated the need to strengthen the Forum's role in the monitoring of the harmonisation of economic and financial policies by ensuring greater ministerial participation at its meetings.

20. On development issues, Council expressed concern about the difficult economic situation in the sub-region despite more than ten years of pursuing structural adjustment programmes. Council urged Member States to continue their pursuit of economic reforms by adopting growth-inducing budgetary and monetary policies. This strategy would give all countries the same orientation and facilitate attainment of the goals of a single ECOWAS monetary zone and harmonisation and convergence of economic and financial policies. This would also ensure the greater success of SAPs.

21. Council also expressed concern at the high level of the debt stock and debt service in ECOWAS Member States, a situation which greatly undermined development efforts in the sub-region. Emphasis was laid on the need to obtain substantial external debt relief in order that the sub-region may have the resources needed to finance its development. Council, having taken note of the information that Guinea, Guinea Bissau and Mauritania had been accorded debt relief treatment under the Naples Facility, urged the Executive Secretariat to evaluate the new mechanism for the treatment of debt and to evaluate its implications for West Africa. The Secretariat was also directed to monitor developments with regard to multilateral debt restructuring.

22. Council called on the Executive Secretariat to accelerate work on the preparation of the regional development programme and to assemble the necessary body of expertise for the study. Council appealed for the speedy reconstitution of the resources of the African Development Fund (ADF) and IDA in order to make available adequate concessionary funds to support development efforts.

23. Council underscored the need to coordinate integration policies in the sub-region. In this regard, the Secretariat was requested to liaise with UEMOA to explore ways of strengthening regional cooperation.

24. Council adopted the recommendation of the Committee of Governors and the Consultative Forum regarding the status of the ECOWAS monetary cooperation programme and decided as follows:

- Debtor central banks should settle all their WACH arrears by May 1996, in line with the recommendation

adopted by the Committee of Governors at its May 1969 meeting in Banjul;

- WACH should work together with the Secretariat and the Central Banks to study the modality of introducing a West African traveller's cheque, for consideration by the Governors;
- The Secretariat should, in conjunction with WACH, expedite action on the study on a Credit and Guarantee Fund, to be presented to the Committee of Governors for appraisal;
- Member States should effect the speedy removal of all non-tariff barriers, particularly those of a monetary nature;
- Member States which are yet to ratify the Protocol establishing WAMA should do so as soon as possible;
- Council urged the Governors to embark upon the following medium and long term measures:
 - readjustment and harmonisation of exchange rates;
 - adoption of an ECOWAS exchange rate system comprising a central parity and a fluctuation margin to be determined;
 - liberalisation of exchange control;
 - maintenance of fiscal discipline;
 - adoption of a market-oriented approach in the utilisation of available instruments of monetary policy.

25. Council was of the view that harmonisation of economic and financial policies was a means of achieving the objective of regional integration. The Secretariat was therefore directed to continue to look into ways of fine-tuning the convergence criteria and to define a clearer and more detailed mechanism for multilateral surveillance. Council called on Member States to accord Central Banks the necessary autonomy and independence to enable them fulfil their price stabilisation role.

26. Council urged Member States to support the bid for the headquarters of the African Centre for Monetary Studies (ACMS) to remain in Dakar.

Item 7 Consideration of the report of the Board of Directors

27. The Chairman of the Board of Directors presented the report of the thirty-third session of the Board.

28. After deliberations, Council took note of the report of the Board of Directors and considered the following issues:

i) ECOBANK

29. Council deplored the fact that the minority shareholders enjoy more privileges than the majority shareholder who played a major role in the establishment of the bank. Council therefore directed Management to take the necessary steps first to obtain preferential status and then to obtain cancellation of the status altogether. If this should become impossible, the Fund was requested to engage the services of legal experts to rectify the situation. In the meantime, the Fund Management should not make any more investments in ETI.

30. Council decided to set up a commission of inquiry composed of the Governors of BCEAO and Bank of Ghana to carry out investigations into the investments made in ETI by the former Fund Managing Director who is the current Chairman of the ETI Board of Directors, with a view to determining whether his actions were due to errors of judgement or whether they were deliberately carried out as a result of conflict of interests.

ii) Loan granted by the Fund towards the construction of the ECOWAS Executive Secretariat Headquarters

31. Council recalled Decision A/DEC/5/7/87 of the Authority of Heads of State and Government directing the ECOWAS Fund to contribute 60% of the amount required for the construction of the Executive Secretariat Headquarters in Abuja.

32. Council also recalled that at its December 1994 session, it was accepted in principle that the amount of UA 10 650 298 disbursed by the Fund be treated as a concessional loan granted to the Executive Secretariat, and that the Administration and Finance Commission had been directed to define modalities for sharing the debt among Member States for repayment and to present a report to the Authority for consideration.

33. This proposal was also part of the measures aimed at strengthening the Fund resources to enable non-regionals to participate in the Fund's capital.

34. In view of the objections raised by some delegates with regard to this proposal, Council decided to submit the following

three options to the Authority of Heads of State and Government for a decision:

- a) The Executive Secretariat Headquarters should be considered as an asset of the Fund, given the Fund's participation in the construction of the Headquarters. The Secretariat should, therefore, be made to pay a rent or to acquire it on hire purchase. An agreement on the transaction should be concluded between the Executive Secretariat and the Fund.
- b) The Fund's contribution should be transformed into a long-term loan granted to Member States. A three-year moratorium beginning from the end of the arrears payment rescheduling agreement period is therefore proposed. Council decided to refer the issue of the assessment formula to the Authority of Heads of State and Government for a decision.
- c) The Fund's contribution should be considered as a grant to the Executive Secretariat.

iii) Issue of BCCI and Meridien International Bank Limited

35. Council expressed great concern at the freezing of the ECOWAS Fund resources at the BCCI (US\$ 6 376 071.58 and £2 330 725.69) and Meridien International Bank Limited (US\$ 3 600 000) both of which have gone into liquidation.

36. Council took note of the efforts being made by the Fund Management to recover the frozen amounts and directed it to intensify its efforts by taking immediate legal action.

37. Council requested the Commission of inquiry composed of the Governors of BCEAO and Bank of Ghana to examine the placement policies, and the measures taken by the Management of the Fund to recover the funds and to determine the culpability of the officials who made the investments.

38. Concerning the disciplinary measures taken against the Treasurer of the Fund, Council endorsed the view expressed by the Board of Directors that this falls under the purview of Management. Council however mandated its Chairman to hold consultations with the Fund Management to ensure that the disciplinary measures taken against the official are in line with the provisions of the Staff Regulations.

iv) Cancellation of the balance of the ADB Line of Credit

39. Council took note of the cancellation by ADB, at the request of the Fund Management, of the balance of the line of ADB credit granted for the implementation of certain projects and commended the initiative taken by the Fund Management.

40. The Fund Management was requested to provide in future all necessary information demanded by Member States concerning projects and, in particular, the information on the projects in Senegal.

Item 8 Report of the 5th Meeting of the Ad-Hoc Ministerial Committee on the enhancement of the Fund's financial resources

41. The Chairman of the Ad-Hoc Ministerial Committee presented the report of the Committee's Fifth Meeting. After an exchange of

views, Council approved:

- the revised budget amounting to UA 698 057 for the study on the enhancement of the Fund's financial resources;
- the selection of Maxwell Stamp Plc to conduct the study for the restructuring of the Fund;
- the schedule for the conduct of the study as embodied in the report of the Ad-Hoc Ministerial Committee.

42. The Fund Management was directed to initiate negotiations with the consultancy firm without delay with a view of reducing both the duration and cost of the study.

Item 9 Consideration of the Ad-Hoc Ministerial Sub-Committee on selection and evaluation of the performance of statutory appointees

43. Presenting the report, the Chairman of the Sub-Committee observed that adequate information had not been made available to facilitate the evaluation of the statutory appointees.

44. In order to ensure an objective and accurate evaluation, the Secretariat was directed to provide each committee member with the following information:

- curriculum vitae of statutory appointees;
- the schedule of duties of each statutory appointee;
- list of directives given to each statutory appointee by Council;
- a report by each statutory appointee stating how far the mission assigned by Council had been implemented;

- a summary of the duration, objectives and outcome of missions undertaken.

45. A month before each summit meeting of the Authority, the Chairman of the sub-committee shall send a report to members on the level of performance expected of the statutory appointees to be evaluated. A team would visit the Executive Secretariat and the Fund to gather all necessary information.

46. The sub-committee was of the view that this new system of appraisal would result in enhanced performance of the staff members concerned and should therefore not be perceived as a sanction.

47. Council adopted the report of the sub-committee.

Item 10 Consideration of the Report of Ministers of Health

48. The report of the second meeting of the Ministers of Health was presented by its Chairman, Commodore Steve OBIMPEH, Ghana's Minister of Health. The report stressed the necessity for accelerating the process of merging the "Organisation de Coordination et de Coopération pour la Lutte Contre les Grandes Endémies (OCCGE)" and the West African Health Community (WAHC), on the expansion of the implementation committee and the creation of a ministerial committee to monitor the merger.

49. Council adopted the recommendation of the Assembly of Ministers of Health and the draft decision relating to the merger of OCCGE and WAHC, attached as an annex to this report.

Item 11 Consideration of the reports of Technical Commissioners

i) Trade, Customs, Immigration, Money and Payments

50. The report of the 34th meeting of the Commission presented by its chairman focused on the following:

- Applications for approval of new industrial products and enterprises for inclusion in the ECOWAS Trade Liberalisation Scheme;
- Implementation of the trade liberalisation programme;
- Draft Protocol establishing Value Added Tax in Member States;
- Draft Protocol on conditions for the application of the Community Levy for financing the activities of the Community.

51. Council adopted the list of fifty-eight new industrial products for inclusion in the trade liberalisation scheme. The decision establishing the list of industrial enterprises and products is attached as an annex to this report.

52. Council also approved the recommendations pertaining to the implementation of the trade liberalisation scheme, compliance with approval procedures and realisation of the ASYCUDA regional project.

53. With respect to the draft protocol establishing Value Added Tax (VAT) and the Protocol on the conditions for application of the Community Levy to generate funds for Community activities, Council decided that in view of the highly technical and political nature of these issues, they should be examined by a

special meeting of tax and customs experts. The special meeting should take place before the November 1995 session of Council to which the experts would submit their report.

54. Council requested Member States to forward to the Executive Secretariat by the end of September, their technical observations on the two draft Protocols so that these would be reflected in the memorandum for presentation to the special meeting.

55. Council further directed the Executive Secretariat to take necessary measures to translate documents into Portuguese to facilitate participation of Cabo Verde and Guinea Bissau at statutory meetings, and to accelerate the ratification of Community texts by these Member States.

ii) **Report of the Administration and Finance Commission**

56. In adopting the report of the Administration and Finance Commission which was presented by its Chairman, Council expressed the view that the missions for the recovery of contributions were necessary and should be undertaken by the institutions as quickly as possible.

**Item 12 Consideration of the Memorandum on the meeting of
Legal Experts**

57. The memorandum presented by the Chairman of the Legal Experts focused on the reconstitution of the archives of the Executive Secretariat, harmonisation of commercial laws of Member States and establishment of an ECOWAS Committee of Legal Experts.

Secretariat to reconstitute the archives of the Secretariat without delay; the exercise was to be undertaken in accordance with the procedure proposed by the Committee of Experts.

59. Council approved the setting up of a committee of eminent persons to study the issue of harmonisation of commercial laws, pending the entry into force of the revised Treaty which envisages the creation of a Commission on Political, Judicial and Legal Affairs, Regional Security and Immigration.

60. Council approved the recommendation concerning the establishment of a committee of legal experts to meet once a year.

Item 13 **Consideration of the Memorandum on the status of financial contributions**

61. Council expressed concern at the high amount of arrears of financial contributions to the various budgets of the Community. As at 25 July 1995, Member States owed a total of US\$ 40, 404,512 to the budget of the Executive Secretariat and US\$ 104,323,770 to the account of the ECOWAS Fund. Council urged all Member States to conclude a schedule of payment of arrears and to respect the provisions and conditions of such agreements.

item 14 **Consideration of the memorandum on the status of ratification of Protocols and Conventions**

62. The tables of ratification of the revised ECOWAS Treaty, the protocols and conventions showed that, as at 25 July 1995, only eight Member States had ratified the revised Treaty. Council repeated its appeal to all Member States to ratify the revised

Treaty before the end of December 1995 and the other acts and decisions of the Community before July 1996.

Item 15 Consideration of the Memorandum on the Merchant Ship "MV SEA ROSE" in the Custody of ECOMOG

63. Council took note of the memorandum presented by the Executive Secretariat on the seizure by ECOMOG of the Merchant Ship "MV Sea Rose" with a consignment of uniforms, arms and ammunition. The dispute between ECOMOG and the Government of Liberia was referred to the Authority of Heads of State and Government for a decision to be taken. The Secretariat was requested to submit to the Authority a detailed memorandum on this matter.

Item 16 Consideration of the draft agenda of the Eighteenth Ordinary Session of the Authority of Heads of State and Government

64. The draft agenda of the eighteenth ordinary session of the Authority of Heads of State and Government was adopted.

Item 17 Other Matters

65. The Assistant Director-General and the Regional Representative of FAO in Africa read a letter on behalf of Mr. Jacques Diouf, Director-General of FAO. The letter contained an FAO plan to organise a World Food Summit in Rome in November 1996 aimed at raising awareness, increasing political will at the highest level, and sensitising public opinion on the unacceptability of continued food insecurity in a world with a constantly growing population, and of the need to redress this situation. Council approved this initiative and recommended

that the Authority pass a resolution to support the participation of the sub-region at the Summit and lend support to EEC programmes and policies.

66. With regard to the fourth United Nations Women's Conference scheduled to take place in Beijing in September 1995, Council decided to submit a draft resolution to the Authority to support the West African Women's Association and national bodies for the advancement of women in order to ensure their effective participation in the Beijing Conference.

67. The delegation of the Federal Republic of Nigeria informed Council of the proposal by Mrs. Ebun Akinola Oyagbola, Chairperson of the International Delphic Council and a former Council member to organise "Delphic Games". Council took note of this information and called on the Executive Secretariat to study the project and submit it to the Social and Cultural Affairs Commission for consideration.

68. With regard to West African representation on the Board of Directors of the Global Environmental Facility, Council noted that the information available to it was insufficient to allow a decision to be taken on the choice of the two representatives.

69. In view of the urgency of the matter, Council decided to refer to the Authority of Heads of State and Government the choice of the two countries and the alternate country to represent the sub-region.

Item 18 Adoption of Report

70. This report was adopted.

Item 19 Closing Session

71. In his closing remarks, Mr. Victor SELORMEY, the Ghana Deputy Minister of Finance and Economic Planning, acting on behalf of the Chairman of Council, thanked members of Council for their active participation in the deliberations. He recalled the necessity for all Member States to manifest greater commitment in support of ECOWAS activities. In this regard, he advised that Member States should honour the undertaking made at this session to pay their contributions, ratify and apply the protocols and conventions of the Community. The Minister proposed that to commemorate the twentieth anniversary of ECOWAS and immortalise the Community ideal, a major street in each national capital should be named "ECOWAS Street".





1. The meeting of ECOWAS Legal Experts is hereby institutionalised and shall be held at least once a year.
2. The meeting of ECOWAS Legal experts shall first consider all proposals before they are submitted to either the meeting of Ministers of Justice and the Council of Ministers.

Article 2

The meeting of ECOWAS Legal Experts shall assist the Executive Secretariat to :

(i) define strategies for and elaborate draft texts for the harmonisation of domestic laws of Member States ;

(ii) consider various draft texts prepared by the Executive Secretariat;

(iii) monitor and assess the implementation of ECOWAS texts that have entered into force;

(vi) exchange information and propose modalities for the creation in the Executive Secretariat, of a legal library and data bank on legal and judicial matters;

(v) prepare action plans, define projects and elaborate programmes and time tables;

(vi) identify sources of extra-budgetary funding for projects and programmes;

(vii) carry out all other functions as may be assigned to it by the Ministers of Justice meeting and the Council of Ministers.

Article 3

The meeting of ECOWAS Legal Experts shall be composed of seasoned professionals chosen by Member States from among officers with the right qualifications and experience to discuss the issues on the Agenda.


Article 4

The meeting of ECOWAS Legal Experts shall be convened by the Executive Secretariat, either on its own initiative, on the directives of the Authority or Council or, at the request of a Member State.

Article 5

The Executive Secretariat shall be responsible for the implementation of this decision which shall enter into force upon signature and shall be published in the Official Journal of the Community and in the National Gazette of each Member State.

DECIDES

Article 1

Member States hereby undertake to harmonise their commercial laws.

Article 2

Pending such a time that the Commission on Political, Judicial and Legal Affairs, Regional Security and Immigration established by Article 22 of the Revised Treaty becomes operational, the Executive Secretariat shall constitute a Committee of three eminent personalities, each of whom should represent one of the three linguistic areas of the Community.

Article 3

The Committee shall work with highly qualified specialists in commercial laws of the region and shall :

- (i) collect and collate all texts on commercial law in Member States;
- (ii) advise on the appropriate structures to be established for the harmonisation exercise;
- (iii) gather all available information from relevant resource persons on procedures and practises relating to Commercial laws in Member States ;
- (iv) identify and prioritise those areas of commercial law to be harmonised;

- (v) Assist the Executive Secretariat, in seeking funding from appropriate organisations and institutions for the harmonisation exercise.

Article 4

The Executive Secretary shall report to the decision-making organs of the Community on this issue as early as practicable.

Article 5



Member States which ratify the ECOWAS Revised Treaty as well as the Protocols and Conventions within the period prescribed in Articles 1 and 2 above shall deposit the instruments of ratification with the ECOWAS Executive Secretariat not later than 31 January, 1996 for the revised Treaty, and by 31 July, 1996 for the Protocols and Conventions.

Article 4

The Executive Secretariat shall be responsible for monitoring the ratification by Member States of the Community Revised Treaty, Protocols and Conventions.

Article 5

This Decision shall enter into force upon signature and shall be published in the Official Journal of the Community and in the National Gazette of each Member State.

CONSIDERING that, having amassed arrears of contributions, most Member States currently owe vast amounts to the Community Institutions, which, if not paid within a reasonable time frame, may bring these institutions to a halt and jeopardise the very existence of the Community;

CONSIDERING that the above Resolution A/RES.1/5/90 provides for the application of sanctions only in cases of non-payment of contributions to the 1990 budget of the Community institutions and for non-payment of subscriptions to the first and second tranches of the called-up capital of the ECOWAS Fund as at 31 December 1992;

CONSIDERING the need for Member States to make available promptly to the Community Institutions adequate financial resources with which to execute Community programmes and ensure the functioning of the Community;

CONSIDERING Resolution C/RES.2/7/95 adopted by the thirty-seventh session of the Council of Ministers held in Accra from 24 - 27 July 1995;

D E C I D E S

Article 1

No new statutory or professional post within the Community Institutions shall be allocated to Member States which are in arrears of contribution and which:

- a) have not agreed a payment schedule with the Executive Secretariat or the Fund by 31 December 1995;
- b) having signed an agreement with the Executive Secretariat or the Fund, have defaulted in the settlement of two consecutive instalments; or
- c) to meet their financial commitments to the Institutions for the current budget year, and as a result, incur fresh arrears by 31 December of each year.

Nationals of Member States in arrears of contributions and to which any of the above situations apply may not be appointed to a statutory or professional post within the Institutions of the Community.

Article 2

In addition to the sanctions set out in Article 1, Member States against which the provisions of that article are applicable shall be divested of their voting rights.

Article 3

The Community Institutions shall not initiate any studies or undertake any project evaluation in defaulting Member States which have arrears of contributions and to which paragraph (a), (b) or (c) of Article 1 above applies. All loan disbursements to such countries are to be suspended.

Article 4

Member States in arrears of contributions and which have not signed a payment agreement with the Executive Secretariat or the Fund by 30 June 1996 and Member States which, having concluded on a payment agreement with the Community Institutions, have defaulted in the payment of more than two consecutive repayments shall be suspended from taking part in the activities of the Community.

Article 5

Settlement of their arrears shall not preclude the Member States from complying with of the provisions of Article 3 of the Protocol on the contributions of Member States to ECOWAS budgets with regard to the budget for the current year.

Payment of their arrears shall not obviate the need for Member States to honour their financial obligations deriving from the application of the Protocol on the Community Levy.

Article 6

The Executive Secretary and the Managing Director of the Fund shall, each in his own capacity, oversee implementation of this Decision.

Article 7

This Decision shall enter into force upon signature and shall be published in the official journal of the Community and in the Gazette of each Member State.



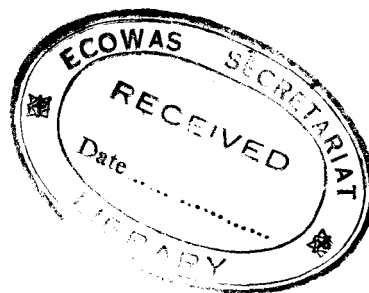
